The M.E. (Master of Engineering) admission to the above engineering courses is covered under Centralized Admission Process (CAP) carried out by the Competent Authority of the State of Maharashtra. CAP provides a platform for the students to apply online for master's programmes, based on their Positive (Non Zero or Non Negative) Graduate Aptitude Test in Engineering (GATE) score of respective year examination, in colleges across the State of Maharashtra.

2] Admission Process

i] Centralized Admission Process (CAP)

The Institution shall admit Candidates through the Centralized Admission Process (CAP) as per rule in the Information Brochure of Post Graduate Technical Courses

ii] Admissions in Institutional Quota and vacant seats after CAP

Apart from centralized admission process, admissions are also available for Seats offered at institute level. These Admissions will be made as per the procedure laid down in the Rule of PG Information Brochure. For such admissions candidates will have to, in person, apply directly to the Principal Modern College of Engineering with all original certificates & documents.

3] Fee Structure

This is based on the relevant norms for the courses and the endorsement from Shikshan Shulka Samiti, a statutory body of Government of Maharashtra and is given in the link "Fee Structure of the Institute" of this institute's website.

For payment of the fees, two separate demand drafts (DD) should be drawn as mentioned in the feestructure in favor of The Principal, PES Modern College of Engineering, Pune 5. DDs should be Payable at Pune. Candidate should write down his/her name & the discipline in which admission is sought on the back side of the DDs.

4] Scholarships:

For receiving Post Graduate scholarship a candidate must have qualified in GATE with valid GATE Score. However, a GATE qualified candidate does not automatically become eligible to receive a scholarship. In fact, only a limited number of scholarships are available at the Institutes from AICTE. These scholarships will be offered to the GATE qualified candidates only, strictly on the basis of valid GATE score MERIT, i.e., candidates must have marks (out of 100) greater than or equal to qualifying marks in respective caste category and continue to receive the same, provided they fulfill the conditions prescribed by AICTE/Institute, from time to time.

5] Conduct & Discipline

Every student admitted to the College for the Academic Term shall be compulsorily required to sign an undertaking that he/she will abide by all the Rules as laid by the institute and parent trust and that he/she will fulfill the minimum attendance requirement as per the provisions of UoP. Parents/guardians are requested to keep track of their ward's attendance in classes. A student will also have to give an undertaking supportive of anti ragging as per the provisions of law. This undertaking duly filled in, signed and sworn by the student and his/her parent is to be submitted to college office at the time of Registration.

Students while studying in the College, if found indulging in anti-national activities contrary to the provisions of acts and laws enforced by the Government, any activity contrary to rules of discipline will be liable to be expelled from the college without any notice.

 - o involve physical assault or threat, and/or use of physical force
 - o violate the status, dignity and honor of women students
 - o violate the status, dignity and honor of students belonging to the SC and ST
 - o expose students to ridicule and contempt and affect their self-esteem
 - o entail verbal abuse and aggression, indecent gestures and obscene behavior
